

**NOTICE TO EMPLOYEES
FROM THE
EMPLOYMENT APPEAL BOARD (EAB)**

Previously, EAB certified AFSCME Iowa Council 61 as the exclusive bargaining representative for the bargaining unit of State of Iowa employees described at the end of this document.

Iowa law requires EAB to conduct retention and recertification elections. In this election EAB will ask the employees in the bargaining unit whether they wish to retain and recertify AFSCME Iowa Council 61 as their exclusive bargaining representative for purposes of collective bargaining.

Iowa law also requires that AFSCME Iowa Council 61 pay an election fee. This fee must be paid by Thursday, September 19, 2024.

If AFSCME Iowa Council 61 does not pay the election fee when it becomes due, EAB will revoke its certification. If EAB revokes the certification of AFSCME Iowa Council 61, your collective bargaining agreement may become void and the terms of the agreement may become unenforceable.

IF AN ELECTION IS HELD, your employer shall post and distribute, in mid-September, a Notice of Election giving details on how and when to vote. The election period will be from 7:00 a.m. on Tuesday, October 08, 2024, to 9:00 a.m. on Tuesday, October 22, 2024. The election will be conducted by the Employment Appeal Board and your right to a secret ballot and a free choice will be protected.

Activities Spec 2 Supv; Chief Hlth Profs Investigator; Dir of Activities; Dir of Nursing; Food Svcs Dir 1, 2 & 3; Food Svcs Asst Dir; Hlth Profs Investigator; Nurse Supv 1 & 2; Nursing Standards Repr; Nursing Svcs Dir; Occupational Therapist 2; Pharmacy Supv.; Psychologist 4; Treatment Program Admin; Treatment Program Coord; Treatment Program Supv; Treatment Svcs Dir; including the classifications of Nurse, Pharmacist, Health Aide Coordinator and Assistant to the Dir of Cardiac Rehabilitation under the jurisdiction of the State Board of Regents
