Please find enclosed update pages to the Accounting Policy and Procedure Manual. Please pay close attention to procedure 210.130 which contains the new mileage reimbursement rates effective 7/1/00. Some procedures include fairly minor changes, and since the intent of the procedure did not change, entire procedures were not reissued. The effective date of the page revision is directly under the effective date of the policy to help ensure that you are using the proper revised page.
