The Internal Revenue Service (IRS) states that Taxpayer Identification Numbers (TINs) are used to associate and verify amounts reported to the IRS with corresponding amounts on tax returns. Therefore, it is important that correct TINs are furnished for vendors of the State. The TIN for an individual is the Social Security Number (SSN). For other recipients, it is the Employer Identification Number (EIN).

It is important to obtain the correct TIN from the vendor. Incorrect vendor information creates potential penalties for the State of Iowa. The IRS penalty for incorrect vendor numbers is \$50 per occurrence. It is the department's responsibility to obtain and submit the correct TIN. Any fines issued to the State of Iowa for an incorrect TIN will be passed on to the entering department. If the department can prove the vendor supplied the incorrect information, they can pass the fine on to the vendor. The best way to prove this is with a signed W-9 from the vendor. The <u>Substitute W-9</u> form is available on the SAE website.

It is also important to receive and maintain correct address information to better ensure warrants and 1099s are delivered properly and timely.
