Call to Order and Introductions

Site Features

Suzy Trotter reported the Monument Conservation Fund raised \$215.982.40 through private donations, a legislative match and interest since the beginning of the project in 2017. Per the direction of the Commission, DAS has allocated \$214.349.00 of the funds for the restoration of the non-endowed monuments on the Complex.

Suzy Trotter reported Dimensional Innovations is not able to provide a timeline for the install of the Holocaust Memorial due to unforeseen issues with sandblasting and its powder coat process.

Staff Reports/Project Updates

Legislative Update

Suzy Trotter reported on behalf of Tami Wiencek, there are no legislative updates.

Chair Renaud requested an update regarding the FY2022 Annual Report concerning the Commission's FY2024 recommendations, specifically, the request of the Legislature to remove the match requirement for the Monument Conservation Fund and issue the remaining funds to the Commission for maintenance of non-endowed monuments. The FY2022 Annual Report was submitted in January 2023. DAS is not aware of any further discussions.

Construction Update

Suzy Trotter reported on behalf of Charlee Cross. Current projects include include ice mitigation on the east elevated walkway at Hoover, repairs to Parking Lot 1 and repairs to the parking ramp.

Mark Willemssen reported the Capitol Building projects include the replacement of deteriorating bricks in the smaller domes from water infiltration, gutter improvements, and window painting. The north domes are complete. The project included replacing the House Chamber skylights. Contractors are working on the south domes and are replacing the Senate Chamber sky light. Work should be done in November of this year.
