IMPORTANT INFORMATION

Important Information

If you drop your State of Iowa health or dental plans there is no provision to rejoin the group.

If your spouse is covered under the State of Iowa's health or dental plans at the time of your death, your spouse can continue coverage.



You may remove a spouse or dependent at any time.

Important Information

- You can only enroll a family member during a qualified life event or annual Enrollment and Change.
- If you are becoming Medicare eligible in 2024, there is no need to do anything during enrollment and change. You will be sent a packet of information approximately three months prior to turning 65.
- If you or any of your dependents become Medicare eligible when on retiree insurance, you MUST enroll in Medicare Parts A and B and Medicare becomes the primary payer at the time of eligibility. If you do not enroll in Medicare Parts A or B, you will be responsible for the portion that Medicare would pay.
