These rules provided process and procedures for records held in temporary custody at the state records center managed by the commission and the state archives and records program.

No. The chapter is outdated. From 2018-2020 that State Archives and Records Program worked with agencies to empty the temporary records center. It was closed in June 2020.

There are no costs to be incurred.

There were no costs to the agencies. However, the annual cost to the State Archives and Records Program was approximately \$400,000. That included staff, rent, and administrative costs.

They did to a point. In 2017 analysis of records found that more than 80% of the records in the records center were beyond their scheduled retention or were scheduled too long. The commission and the State Archives and Records Program worked with agencies over three years to make the required changes.
