## DAS Purchasing Receives National Excellence Award

The central purchasing authority for the State of Iowa has received an Annual Achievement of Excellence in Procurement Award (AEP) for 2011 from the National Purchasing Institute.

In receiving the award, the Procurement division of The Department of Administrative Services was recognized for best practices in staff certification and training as well as performance measurement, electronic and cooperative procurement and continued improvement. A bulk of the criteria for winning this prestigious procurement award was identifying cost savings, a specific area of focus for DAS Procurement. This award is the gold standard in the industry of public procurement.

In winning the award, DAS-Procurement scored 150 out of a possible 175 points, placing them in the top 20 percent of a field of 181 applicants. Ten state-wide procurement offices won the award (including the District of Columbia). Other winners included counties, municipalities and public institutions such as state colleges and universities. DAS Procurement works with and trains purchasing agents from other Executive branch agencies in implementing best practices on the behalf of state government.

The annual AEP Award is sponsored by the National Purchasing Institute, the Institute for Supply Management, the California Association of Public Purchasing

## Des Moines Again Selected for SBA Program

For the last four years, Des Moines has been selected as one of a limited number of cities nationwide to participate in the Small Business Association's (SBA) Emerging 200 Initiative (e200). The goal of the e200 is to identify inner-city businesses across the country that show a high potential for growth and to provide them the network, resources and motivation required to build a sustainable business within a designated inner-city geographic location. Based on the success of the initiative in Des Moines over the last three years, SBA is offering the program in the city again and class sessions ran from April 14, 2011 – October 14, 2011. The class sessions were held in room 121 of the Betts Building on the DMACC Urban Campus.

DAS Procurement's Lois Schmitz presented at the September 15th meeting and had

an opportunity to share some insights that would be helpful to inner-city businesses as they seek to establish and grow their client base. She was able to offer valuable insights to this group of entrepreneurs on bidding for business opportunities with the state. A volunteer from the class had the opportunity to use the electronic bid system to register for notice of state RFPs as an example for the class. This demonstration made the state process more understandable for those involved in the program, most of who had never bid on state work before.

Procurement professionals from the county were also on hand to offer insights on their procurement processes. Program participants valued the opportunity to learn helpful tips from both a county and statewide perspective.

## Contract Curiosity Uncovers Interesting Information

The State has a contract with a company that provides food thickeners used primarily by DHS residential facilities and The Veterans Home. When this contract came up for renewal, procurement professional Andrew Saxton inquired what food thickener was and how it was used.

"My first thought was that it was used in cooking gravies and sauces but our knowledgeable state dieticians advised me that the use of this thickener aids residents that have trouble swallowing thin liquids," Saxton discovered.

The State's contracted vendor provides a food thickener that comes from xanthan gum (pronounced zanthan) which is bacteria that grows primarily on vegetables like broccoli and cauliflower. Bacteria certainly does not sound appetizing but

it forms a slimy substance that acts as a natural food thickener. Premeasured amounts of the xanthan gum from our vendor's own patented process, when added to a specific volume of liquid such as juice, coffee, etc... creates a stable thickener which can be classified using the words: nectar, honey, or pudding to describe the thickness. Another interesting property of xanthan gum is that shaking and pouring it thins it then it thickens back up to its original consistency as it stops moving.

So next time you are in your local grocery store take a look at the ingredients on your salad dressing, ice cream, and toothpaste as well as many other items and you will see xanthan gum listed. We have a research team at the United States Department of Agriculture to thank for this discovery.

## Regional Pharmaceutical Contract Produces Savings

DAS Procurement manages the master agreements for the purchase of pharmaceuticals and other health care products and services such as, medical supplies, influenza vaccine, dental supplies, and drug testing supplies.

In 2004, the State of Iowa joined the group purchasing organization, Minnesota Multistate Contracting Alliance for Pharmacy (MMCAP). The MMCAP membership currently consists of 46 states and the cities of Los Angeles and Chicago. MMCAP is a free, voluntary organization for government facilities, such as state agencies, correctional, counties, cities, school districts and public higher education facilities. MMCAP contracts with the major pharmaceutical manufactures, medical and dental equipment suppliers to negotiate pricing for the members.

DAS Procurement with the Departments of Human Services, Public Health and Corrections coordinated efforts to change the purchasing of medications for state agencies.

Department of Corrections has received the largest impact of the savings by procuring the pharmaceuticals for the Central Pharmacy through the MMCAP contracts. To learn more about the DOC Centralized Pharmacy program read the Legislative Services Agency, Issue Review, February 4, 2011. From the Issue Review, "If the cost of drugs and biologicals continues to increase at the current rate, annual costs will total approximately \$27

million in 10 years. If the DOC and other governmental agencies cooperate, this projected increased cost could be reduced or contained through bulk purchasing, technology, administrative efficiencies, and statutory changes."

DHS transitioned five facilities to the MMCAP contracts on October 1, 2011. This change is estimated to save \$16,000 per year on the medications that are currently used at five facilities. Savings is extrapolated across to the local public health facilities and the rest of state government by:

1. Volume discounts, our cost of goods discount for the state was -1.27%, now with the addition of the five DHS facilities our discount will be -1.50%,
2. Market share programs and additional reduced pricing opportunities for agencies meeting certain criteria,
3. Share back credits given to the members once a year from the administration fees collected from the drug manufactures as part of the contract. In FY11, MMCAP collected \$9.7 million in administration fees and returned \$6.3 million to the members in the form of a credit.

This effort has been in process for several months. Currently, all DOC sites, 5 DHS sites, DPH and 20 local public health offices are members of MMCAP and able to procure medications and supplies from the MMCAP contracts to receive the savings.
