## Master Plan

Vice Chair Seelman reported there were no updates to the Master Plan. Vice Chair Seelman invited other Commission members to join the Master Plan Committee.

## Site Features

Carol Grant presented the Monument Conservation Fund Report dated December 30, 2022. Carol commented the Commission would need to collect approximately \$60,000 in private donations to receive the approximate amount of \$30,000 remaining from the legislative match.

Carol reported there were no monument applications to review.

Suzy Trotter reported the Monument Conservation Fund has an available balance of \$18,714.42. Suzy presented three options for the Commission to consider for the use of the available amount. Option one, restore the broken granite on the Christopher Columbus Monument. Option two, preform maintenance as recommended by Smith Art Conservation. Option three, begin the restoration of the non-endowed low priority maintenance not included on the Commission's original strategic plan. The Commission members present at the meeting, requested the Site Features Committee meet with the goal to create a plan for the remaining funds.

#### Legislative Update

Charlee Cross reported the 90<sup>th</sup> Iowa General Assembly, 2023 Legislative Session will begin on Monday, January 9, 2023.

#### **Construction Update**

Charlee Cross report the State Historical Building Skylight Replacement project is substantially complete. Capitol Complex improvements include ongoing sidewalk replacements and parking lot repairs.

#### **Annual Report**

Chair Renaud presented the Capitol Planning Commission FY2022 Annual Report and 5-Year Plan. Chair Renaud provided details of the Commission's recommendations for the future of the Capitol Complex. Malcolm Hankins requested an amendment on Page 1 of 7 from "Malcom" to "Malcolm".
