The Iowa Juvenile Home provides intervention for the most troubled youth in the State with a specialized, structured setting to evaluate and treat 94 males and females between 12 and 18 years of age. They have been adjudicated by the Iowa Court System as Children in Need of Assistance (male and female), or they have been adjudicated Delinquent (females only) and determined by the Juvenile Justice System to require specialized structured program care, evaluation, and/or treatment. Buildings at the 37 Acre campus just north of Highway 30 range in age from 6 years to 85 years old with all but two buildings constructed between 1920 and 1965.
