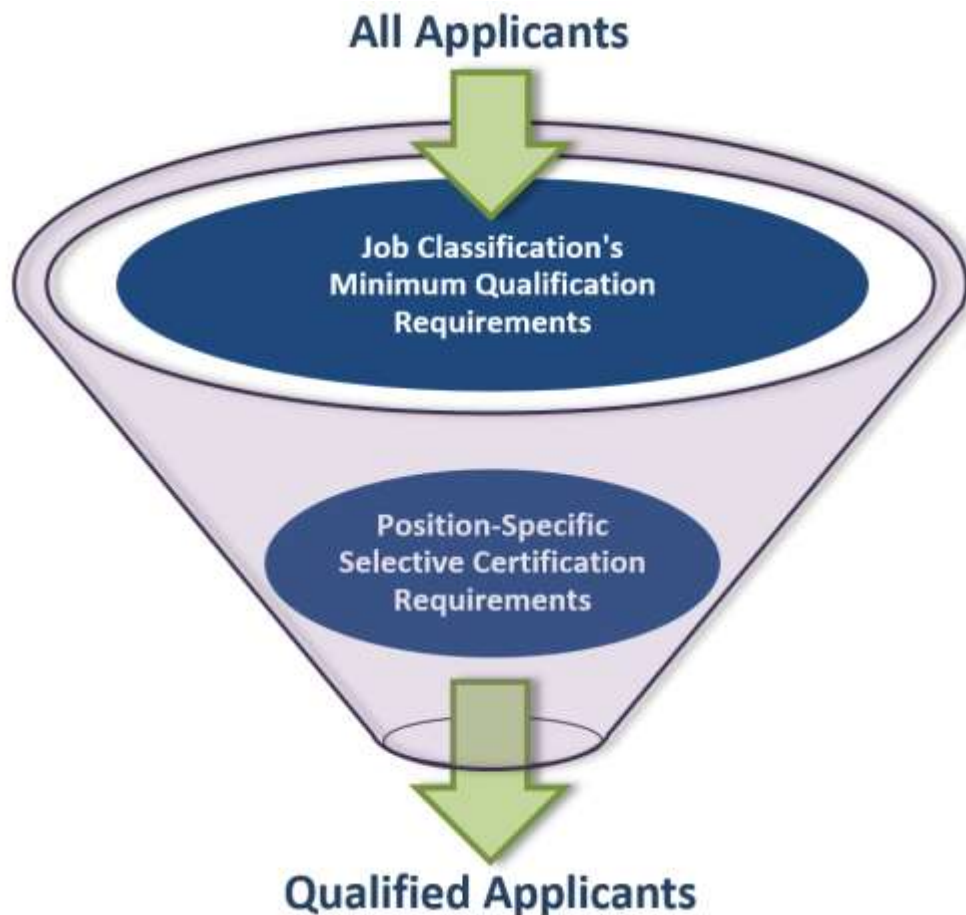

## Introduction to Selectives

Selective certification requirements, known simply as “selectives,” are position-specific additional qualification requirements that are based on the demonstrated job-related needs of an individual position being filled. Not every position will require the use of a selective and some positions may require more than one selective. Each selective used must be directly related to the duties of the job. Using a selective narrows the applicant pool by seeking a more specific type of background *within* the stated minimum qualifications. Selectives do not take the place of the minimum requirements for a vacancy; rather, selectives are necessary, position-specific requirements that an applicant must meet *in addition to* the minimum qualifications listed for each vacancy.

These selective certification requirements are usually based on technical competencies specific to an individual position. Selectives are often expressed as six months of experience or 12 semester hours of education in the selective area, or a combination of both. However, some others may require possession of a specific license, endorsement, or professional certification instead of education or work experience.



As the chart above depicts, in the case of vacancies that require a selective, an applicant is qualified if the minimum qualifications and the selective certification requirements are met. An applicant is not qualified for the particular position if the minimum qualifications for the job classification are met but the position-specific selective certification requirements are not met. In that instance, the applicant could still be qualified for another vacancy in the same job classification that does not require a selective or that requires another selective for which the applicant meets the criteria.

In cases where more than one selective is identified as required for a vacancy, the applicant must meet the requirements for all selectives listed to be considered qualified for the position.

## **Using this Categorical List**

The selectives on this list are sorted by category based on type of requirement. Clicking on the category desired in the Table of Contents below will lead to the selectives found in that category. The selectives in each category are listed numerically by a three-digit selective code. In some cases, a specific selective may be found in more than one category. Specific words can also be searched for in this document by using the *Edit > Find* function (Ctrl + F) in Adobe Reader.

## Categorical Selective List

### Accounting/Budgeting/Finance/Statistics

#### **002 Accounting**

6 months' experience, 12 semester hours, or a combination of both in accounting or the accounting field. Accounting is the measurement, processing, and communication of financial information about economic entities which includes individuals and businesses.

#### **018 Auditing**

6 months' experience, 12 semester hours, or a combination of both in the official examination of and verification of financial accounts and records.

#### **058 Budgeting**

6 months' experience, 12 semester hours, or a combination of both in preparing, analyzing budgets; and providing advice/technical assistance with cost analysis, fiscal allocation, and budget preparation.

#### **069 Clerical Accounting**

3 years' of basic high school math courses (or 12 semester hours of college level basic math courses or above) or 6 months' experience where clerical accounting was a major function of the job which required the following:

- Ability to apply math skills in addition, subtraction, multiplication, division, percentages and fractions and basic algebra to pre-established accounting systems or procedures.
- Ability to use and modify electronic spreadsheet software such as EXCEL
- Ability to interpret and apply fiscal regulations
- Ability to read and understand basic financial and statistical reports

#### **100 Investments**

6 months' experience, 12 semester hours, or a combination of both in one or in a combination of any of the following areas:

- Investment analysis
- Portfolio management
- Work with fixed income securities
- Economics
- Finance

#### **208 Financial**

6 months' experience, 12 semester hours, or a combination of both in one or in a combination of the following areas: accounting, auditing, budgeting, economics, or finance.

#### **209 Student Loan/Financial Aid**

6 months' experience, 12 semester hours, or a combination of both in the administration of college financial aid programs, and/or banking or lending institution or loan servicer involvement as a student loan officer. Specifically applies to work with programs that assist students in seeking finances for college.

#### **210 Finance**

6 months' experience, 12 semester hours, or a combination of both, in one or in a combination of the following areas: introductory or advanced corporate finance; economics, money and banking; financial institutions, instruments and markets, or portfolio analysis.

#### **216 Financial Aid**

6 months' experience, 12 semester hours, or a combination of both in one or in a combination of more than one of the following:

- Educational financial aid
- Educational loans and grants
- Income maintenance

### **218 Economics**

6 months' experience, 12 semester hours, or a combination of both in the social science that studies economic activity to gain an understanding of the processes that govern the production, distribution, and consumption of goods and services in an economy.

### **661 Statistical Data Analysis**

6 months' experience, 12 semester hours, or a combination of both in statistical data analysis including:

- Statistical research
- Analysis or evaluation of statistical data
- Clerical or technical work primarily limited to collecting, compiling, or assembling statistical data should not be counted toward this selective.

### **968 Statistics**

20 semester hours in post-high school coursework in statistics.

## Administration/Business/Insurance/Management

### **061 Business Administration**

6 months' experience, 12 semester hours, or a combination of both in the running of a business.

### **063 Business**

6 months' experience and 12 semester hours or a combination of both in one or more of the following:

- Accounting
- Actuarial science
- Auditing
- Banking
- Economics
- Grant writing
- Grant management
- Finance
- Marketing
- Management
- Personnel
- Public administration
- Management analysis
- Retail business
- Statistics
- Computer science
- Computer information systems
- Business education
- Political science

### **084 Long-Term Care Insurance**

1 year of experience demonstrating technical knowledge (knowledge of the aspects of types of policies, benefits, premiums, deductibles) in long-term care insurance.

### **085 Managed Long-Term Services and Supports**

6 months' experience working with capitated Medicaid or other managed care programs, preferably Managed Long-Term Services and Supports (MLTSS) which refers to the delivery of long-term services and supports (including both home and community based services and institution based services).

## Categorical Selective List

### **086 Business Systems Analyst**

6 months' experience, 12 semester hours, or a combination of both in identifying, documenting, and analyzing business requirements and proposing large and/or complex technology solutions, serving as a conduit for communications between business users and information technology.

### **192 Economic Development**

12 semester hours, 6 months' experience, or a combination of both with emphasis in economic development. Work in business administration, economics, finance, or other related fields should not be counted towards this selective unless the coursework was included as part of an economic development minor or specialty.

Experience counting towards the selective should reflect the following kinds of responsibilities:

- Providing consultation and planning to existing or proposed businesses or firms in developing business plans
- Conducting cash flow analyses
- Evaluating and determining economic feasibility
- Market analysis studies to determine the feasibility of starting or expanding business

### **246 Grant Writing and Management**

6 months' professional level experience as one of a team or as the sole organizational resource managing the grant program, which includes all of the following: writing grant applications/proposals, managing grant funds, providing technical assistance to sub-grantees, monitoring grants, and grant performance reporting. Experience must have been a major or dominant function of the job. May also include experience reviewing, approving/awarding, and monitoring others' grant proposals, but this alone does not qualify.

### **359 Life and Health Insurance**

6 months' experience, 12 semester hours, or a combination of both in any of the following types of insurance contracts:

- Life Insurance
- Health Insurance
- Health Maintenance Organization
- Dental
- Variable Annuities
- Life Annuities

### **364 Long-Term Care**

6 months' experience working in long-term care in an administrative or direct care capacity. Long-term care is defined as a nursing facility, residential care facility, assisted living facility, hospital, hospice, long-term care licensing agency, or Medicaid or Medicare agency.

### **372 Determining Educational/Consumer Loans or Public Assistance Eligibility**

6 months' experience in determining educational and/or consumer loans or public assistance eligibility.

### **415 Mortgage Lending**

6 months' experience, 12 semester hours, or a combination of both.

### **435 Unemployment Insurance, Tax Law, and Collections**

6 months' experience, 12 semester hours, or a combination of both including:

Iowa Unemployment Insurance, tax law and procedures, bankruptcy code, and rules on garnishments and liens

### **482 Office Management**

6 months' experience or 12 semester hours or a combination of both where the applicant has received training in or been in charge of all or part of an office operation that included all or some of the following:

- Correspondence and other files and recordkeeping
- Answering phones and greeting the public
- Cashiering
- Bill collection and payment

- Accounting
- Facility management
- Secretarial and general clerical work

Coursework or experience limited to straight clerical functions is not applicable; the applicant must have education or experience aimed at managing these operations, even in a one-person office, where they were the primary party responsible for them. The applicant may have also supervised other staff but that is not required as long as they were in charge of managing the office or have taken coursework concerned with managing an office.

### **533 Property and Casualty Insurance**

6 months' experience, 12 semester hours, or a combination of both involving any of the following types of insurance contracts:

- Automobile
- Homeowners
- Property
- Malpractice
- Workers' Compensation

### **538 Purchasing**

6 months' experience in the purchasing of expendable/non-expendable goods.

### **564 Government Regulation and Accountability**

Applicant should demonstrate a minimum of 6 months' experience, 12 semester hours, or a combination of both in the area of managing state or federal governmental regulations and implementing accountability provisions.

### **566 Federal Program Experience**

Applicant should demonstrate a minimum of 6 months of work experience managing federal program requirements, expectations, and funding.

### **567 Experience Interpreting Iowa Code and Iowa Administrative Code**

Applicant should demonstrate a minimum of 6 months' experience, 12 semester hours, or a combination of both in the area of developing and interpreting Iowa Code and Iowa Administrative Code.

### **568 Board Management**

Applicant should demonstrate a minimum of 6 months of work experience working with and providing support for a formal board or commission structure.

### **602 Real Estate**

6 months' experience as a real estate agent experience would qualify. If the experience was not in sales, but for instance, in property management or development, it would need to be at a professional level. Office support work in real estate would not qualify. Coursework that is required to achieve a real estate license would be credited towards the 6 months' experience.

### **606 Facility Rental and Event Coordinator**

6 months' experience in charge of all or part of an office operation that included all or some of the following: Event planning and coordination: customer service and communications including answering phones and public interaction; correspondence to clientele, organization of files and recording; invoicing, accounting, expense and revenue management; facility management and coordination of building resources; and fundraising proposal writing and management of contributed resources.

### **621 Service and Performance Contract Negotiations and Management**

6 months' experience, 12 semester hours, or a combination. Differs from labor contract negotiation. These are contracts with various vendors or other service providers and the applicant must have demonstrated experience and/or education that allowed them to review performance and service delivery and know what to do and be able to act when performance

does not meet expectations. Includes: drafting or developing contracts for provision of products and/or services and the related budget components; negotiating the terms of contracts to include: costs, timeframes and performances expectations and/or work products; monitoring and managing all aspects of the contracts: to include timely submission of financial reports, performance reports, work products and determining when appropriate benchmarks for payment of invoices are met. Specific educational courses that relate to the selective might include: contract management, business law, principles of economics, business management and similar courses.

### **649 Safety Programs/Workers' Compensation**

12 months' experience involving responsibility for:

- Planning
- Promoting
- Coordinating
- Enforcing
- Carrying out a safety workplace program

### **704 Senior Health Insurance**

1 year experience, 12 semester hours, or a combination of both, in the following: Long-term care insurance or Medicare supplement insurance

### **710 Federal Motor Carrier Safety Regulations – CDL Program**

6 months' experience in administering, interpreting, and/or enforcing Federal Motor Carrier Safety Regulations related to the state's administering of Commercial Driver Licensing program.

### **729 Business Continuity/Disaster Recovery**

6 months' experience, 12 semester hours, or a combination of both in planning for continuation of critical business functions in the event of a disaster.

### **733 Utility Rate Regulation**

6 months' experience, 12 semester hours, or a combination of both in research and analysis of cost and rate structures of utilities and/or impacts of rate changes on demands for utility services.

### **735 Unemployment Insurance/Claims/Fact-Finding**

1 year combined experience in conducting unemployment hearings and processing unemployment insurance claims.

### **736 Business Process Improvement**

Successful candidates must possess the equivalent of 6 months' full-time experience leading business process improvement events, utilizing Kaizen and other continuous process improvement techniques.

### **737 Information Technology Project Management**

A minimum of 6 months experience, 12 semester hours, or a combination of both, where the applicant has received training in or been in charge of information technology projects that included some or all of the following:

- Coordinating professional, paraprofessional, and technical personnel involved in the development of new and/or maintenance and operation of existing information technology systems;
- Responsible for multiple business and/or computer applications through the development and support phases;
- Initiates in systems analysis studies;
- Evaluates overall and individual work performance to determine effectiveness in providing quality products within time and cost restraints;
- Prepares or reviews written and oral reports of proposed information technology systems;
- Directs applications systems planning and budgeting, and acquisition and acceptance of new equipment for the department;
- Monitors time and dollar expenditures to ensure projects and budgets meet established targets;
- Reviews computer programming techniques and computer usage to ensure efficient and effective procedures are utilized;

- Develops analysis and programming guidelines and documentation standards;
- Evaluates and makes recommendations for needed project team and/or customer training;
- Reviews the designs of computer applications to ensure that all requirements are satisfied;
- Reconciles conflicts within and between staff regarding resources, deadlines, and standards;
- Writes periodic progress, project status and problems resolution reports for management review.

Coursework or experience limited to straight computer programming, systems analysis, or web development is not applicable; the applicant must have education or experience aimed at project management where the applicant was the primary party responsible for the project. The applicant may have also performed other duties or supervised other staff but that is not required as long as the applicant was in charge of managing the information technology project or have taken coursework concerned with managing information technology projects.

### **913 Buildings/Grounds Maintenance Management**

6 months' experience, 12 semester hours, or a combination of both.

### **914 Park and Recreation Management**

6 months' experience, twelve semester hours, or a combination of both in the operation and/or maintenance of parks or park recreational services. May have commonly been served at a national, state, or county park level.

### **916 Electronic Records Management**

The equivalent of six months of full-time experience performing records management functions including the creation, organization, maintenance, administrative use, security, public accountability, storage, retention, conversion of paper documents to digital formats and digital to digital functionality.

### **932 Fundraising for Non-Profit Corporation Board**

6 months' experience, 12 semester hours, or a combination of both in fundraising activities for a non-profit corporation board.

### **980 Strategic Planning**

6 months' experience, 12 semester hours, or a combination of both. Generally, an administrative position (mid to upper level of the management team) is assigned this as one function of their overall job. However, there are some specialists who deal only in strategic planning. Some colleges and universities may now carry this as a major or area of emphasis as part of their business administration or public policy programs. For experience to count, the applicant must have had the responsibility either for coordinating or developing the organization's strategic plan. Sometimes an administrative assistant-type is responsible for a lower level of coordination, i.e., distributing information to managers, collecting what they develop, and putting it into one document; that is not what is sought here. This has to be experience to the point that the individual knows the following:

- What a good strategic plan looks like
- How to prepare a plan
- How to monitor progress and ancillary planning
- How to speak knowledgeably for the organization about the plan

### **998 Member of the Society of Actuaries**

Membership in the Society of Actuaries as one of the following:

- Associate of the Society of Actuaries (ASA)
- Chartered Enterprise Risk Analyst (CERA)
- Fellow of the Society of Actuaries (FSA)

## Agriculture/Biology/Environment

### **006 Agriculture**

6 months' experience, 12 semester hours or a combination of both in agriculture or horticulture. The 6 months' experience must include working on a farm.

## Categorical Selective List

### **008 Air Pollution Control**

6 months' experience, 12 semester hours, or a combination of both in the use of devices or practices to limit or prevent the release of pollution into the atmosphere.

### **039 Agriculture Extension Service**

6 months' experience, 12 semester hours, or a combination of both working with educational and public awareness organizations. The experience/education can be met with 6 months' experience or 12 semester hours or a combination of both in one or in a combination of the following areas:

- Youth programs
- Extension services
- Vocational agriculture: planning, development, and implementation of educational programs
- Public service activities, which focus on the importance of agriculture to the state's economy, culture, and way of life

### **054 Biological Sciences**

6 months' experience, 12 semester hours, or a combination of both in the study of living organisms. It is broadly divided into zoology and botany.

### **108 DNA Analysis**

6 months of full-time experience, twelve semester hours of education, or an equivalent combination of both in the DNA analysis process including all of the following: extraction, quantitation, PCR amplification, and electrophoresis.

### **172 Ecology**

6 months' experience, 12 semester hours, or a combination of both in the study of the relationship between organisms and the environment.

### **183 Environmental Health**

6 months' experience, 12 semester hours or a combination of both in the branch of public health that is concerned with all aspects of the natural and built environment that may affect human health.

### **187 Energy**

6 months' experience, 12 semester hours, or a combination of both in one or more of the following:

- Nuclear energy
- Solar energy
- Fuel allocation
- Hydro-electric energy
- Biomass
- Energy efficiency (meaning experience in environmental stewardship through the development of clean, reliable, and/or affordable energy technologies and programs for buildings, homes, transportation, power systems, and industry)

For use by the Iowa Department of Human Rights, this selective shall mean 6 months' experience, 12 semester hours, or a combination of both in weatherization, including one or more of the following:

- Weatherization Program Manager
- Weatherization Energy Auditor
- Experience with Building Construction and Energy Principles

### **231 Environmental Geology**

6 months' experience or at least one course in the application of geologic principles (including hydrogeology) to problem solving in the areas of safe disposal of solid and liquid wastes, management and protection of water resources and in evaluating the impacts of various land-use practices.

## Categorical Selective List

### **242 Geology**

For use by the Department of Natural Resources, the following shall apply: 12 months of experience, 24 semester hours of education, or a combination of both, practicing geosciences in areas which can include identification, interpretation, and logging of geologic materials, hydrogeology, geologic field work, or geologic mapping.

### **270 Hazardous Waste**

6 months' experience in the disposal and proper handling of waste that poses a substantial or potential threat to public health or the environment.

### **288 Horticulture**

6 months' experience, 12 semester hours, or a combination of both involving the production, processing, sales, or marketing of commercial fruits or vegetables.

### **442 Meteorology**

Undergraduate degree(s) in meteorology or atmospheric science. Internships or work experience related to weather forecasting, atmospheric research, or previous air quality modeling training or work that included processing of meteorological data.

### **449 Natural Science**

6 months' experience, 12 semester hours, or a combination of both in the sciences collectively that are involved in the study of the physical world and its phenomena, including biology, physics, chemistry, and geology, but excluding social sciences, abstract or theoretical sciences, such as mathematics, and applied sciences.

### **450 Natural Resources**

6 months' experience, 12 semester hours, or a combination of both in one or in a combination of more than one of the following:

- Ecology
- Environmental planning
- Soil conservation
- Biological sciences
- Waste water treatment
- Forestry
- Engineering related to natural resource areas (dams, sanitary engineers, etc.)
- Outdoor recreation planning
- Physical sciences
- River basin planning
- Geography
- Wildlife management

### **456 Nutrient Management**

18 semester hours in agronomy, chemistry, water resources, or biological sciences, or 6 months' experience in nutrient management which would have resulted in an ability to demonstrate an understanding of:

- Nutrient loading and transport principles as applies specifically to nitrogen and phosphorus.
- Nutrient management plans for agricultural production.
- Iowa's nutrient budget.
- Environmental principles and terminology in the areas of nonpoint source pollution, nutrients and water quality.
- Nutrient management, soils and agronomic principles and practices.
- Potential sources of NPS pollution, nutrient cycling and effects of nutrients on aquatic ecosystems.
- Nutrients and their relationship to Iowa's impaired waters (Section 303(d) list) and Total Maximum Daily Loads.
- Iowa's Nutrient Management Strategy.
- Ability to write and understand environmental rules, and the ability to communicate effectively the impacts of proposed or adopted rules.

A combination of the required education and experience would qualify.

## Categorical Selective List

### **484 Organic Agriculture**

6 months' experience, 12 semester hours, or a combination of both in an ecological production management system that promotes and enhances biodiversity, biological cycles, and soil biological activity. It is based on minimal use of off-farm inputs and on management practices that restore, maintain, or enhance ecological harmony. The primary goal of organic agriculture is to optimize the health and productivity of interdependent communities of soil life, plants, animals and people.

### **657 Soil Conservation**

6 months' experience, 12 semester hours, or a combination of both in the prevention of soil erosion due to a variety of causes – soil contamination, fires, natural disasters.

### **658 Integrated Solid Waste Management**

The selective can be met with education, experience or a combination of both. Specific criteria may be required for certain positions. Solid waste does not include hazardous waste, animal waste or wastewater.

6 months' experience in:

- Landfill operation
- Recycling education/coordination
- Waste collection
- Solid waste consultant/engineer
- Solid waste management administration
- Solid waste planner (urban/regional)
- A college degree with 12 semester hours in:
  - Waste management
  - Ecology
  - Urban and regional planning (with a solid waste component)
  - Environmental sciences/studies
  - Environmental engineering

### **660 Solid Waste**

6 months of full-time work experience in one or more of the following solid waste areas:

- Facility operation (landfill, transfer station, compost facility, etc.)
- Recycling education and outreach/coordination
- Collection
- Consultant/engineering
- Agency/management administration
- Planning (urban/regional)
- Policy
- By-product marketing

For purposes of this selective, solid waste shall mean garbage, refuse, rubbish and other similar discarded solid or semi-solid materials resulting from industrial, commercial, and/or domestic activities.

### **759 Environmental Compliance Inspections**

6 months' experience, 12 semester hours, or a combination of both.

### **760 Wastewater**

6 months' experience in wastewater treatment which includes any of the following:

- Design of wastewater treatment systems including controlled discharge lagoons, aerated lagoons, activated sludge treatment systems, or on-site systems for municipalities or industries or,
- Issuing or preparing wastewater discharge operation permits for point source discharges of domestic wastewater or industrial discharges or,
- Experience in calculating wasteload allocations or water quality based permit limits for point sources discharges

## Categorical Selective List

### **762 Water Resources**

6 months' experience, 12 semester hours, or a combination of both that encompasses the physical, chemical, and biological aspects of surface and ground water resources including the following:

- Surface water hydrology
- Ground water hydrology
- Hydraulics
- Water resources engineering
- Natural resources conservation engineering
- Water supply engineering
- Water quality engineering
- Erosion and sediment transport
- Surface or ground water chemistry
- Watershed dynamics
- Limnology
- Stream or wetland ecology

The Water Resources selective is distinct from the Water Supply, Waste Water, Water Quality, and Chemistry selectives in that the Water Resources selective applies to the management, engineering, and quality analysis of surface and groundwater resources in the natural environment rather than the processing of water in a waste water or drinking water treatment plant or the analysis of water samples in a laboratory.

### **763 Water Supply**

6 months' experience in the operating of a drinking water (also called water supply) treatment plant or distribution plant. Also, operation of a wastewater treatment plant or distribution system would be acceptable, because many of the principles and mechanics are very similar. 12 semester hours in:

- Specific drinking water treatment
- Wastewater treatment
- Advanced analytical chemistry water/wastewater
- Water resources coursework such as hydrology
- Watershed management
- Hydrogeology

Also, any design courses specifically in water supply (drinking water) or wastewater treatment or distribution systems are acceptable.

### **900 Fisheries Biology**

6 months' experience, 12 semester hours, or a combination of both.

### **901 Wildlife Biology**

6 months' experience, 12 semester hours, or a combination of both.

### **907 Forestry**

12 semester hours, 6 months continuous full-time experience, or a combination of both, in any of the following:

- Dendrology
- Silviculture
- Forest management, tree planting and habitat management
- Timber stand improvement
- Forest planning
- Planning and mapping using Geographic Information Systems (GIS) for forest improvement projects
- Forest inventory including tree identification
- Reforestation and/or forest health data collection and monitoring

### **936 Urban Forestry, Horticulture, or Agriculture**

Nuclear engineering is the branch of engineering concerned with the application of the breakdown (fission) as well as the fusion of atomic nuclei and/or the application of other sub-atomic physics, based on the principles of nuclear physics. In the sub-field of nuclear fission, it particularly includes the interaction and maintenance of systems and components like nuclear reactors, nuclear power plants, and/or nuclear weapons.

### **029 Energy Engineering**

6 months' experience, 12 semester hours, or a combination of both. Energy engineering is a broad field of engineering dealing with energy efficiency, energy services, facility management, plant engineering, environmental compliance and alternative energy technologies

### **030 Telecommunications Engineering**

6 months' experience, 12 semester hours, or a combination of both. Telecommunications engineering is a discipline that brings together electrical engineering with computer science to enhance telecommunication systems. A telecommunication engineer is responsible for designing and overseeing the installation of telecommunications equipment and facilities, such as complex electronic switching systems, copper wire telephone facilities, and fiber optics.

### **031 Engineering Economics**

6 months' experience in calculating the economic value, life cycle cost and benefit/cost ratio of constructing, operating, maintain and decommissioning of utility plant and facilities. Fundamentally, engineering economics involves formulating, estimating, and evaluating the economic outcomes when alternatives to accomplish a defined purpose are available.

### **032 Valuation Engineering**

6 months' experience in determining the fair market value of utility infrastructure, including how long the plant can reasonably be expected to operate at a fair and reasonable price. Value engineering (VE) is a systematic method to improve the "value" of goods or products and services by using an examination of function. It is a primary tenet of value engineering that basic functions be preserved and not be reduced as a consequence of pursuing value improvements.

6 months' experience in determining appropriate depreciation rates, including knowledge of various depreciation methods used for utility infrastructure investment.

### **093 Chemical Engineering**

6 months' experience, 12 semester hours, or a combination of both in the mass production and knowledge of the processes involved in the mass production of chemicals.

### **097 Civil Engineering**

6 months' experience, 12 semester hours, or a combination of both in one or more of the following:

- Survey crew
- Construction inspector
- Professional civil engineer

Must be able to read blueprints, plans, and/or specifications.

### **176 Electrical Engineering**

6 months' experience, 12 semester hours, or a combination of both in the branch of engineering that deals with the technology of electricity, especially the design and application of circuitry and equipment for power generation and distribution, machine control, and communications.

### **182 Environmental Engineering**

6 months' experience, 12 semester hours, or a combination of both in the area of engineering that is centered on the technology concerned with the reduction of pollution, contamination, and deterioration of the surroundings in which humans live.

### **223 Construction Engineering**

6 months' experience, 12 semester hours, or a combination of both in the professional discipline that deals with the designing, planning, construction, and management of infrastructures such as highways, bridges, airports, railroads, buildings, dams, and utilities.

### **264 Heating, Ventilation, and Air Conditioning Engineer**

12 semester hours coursework in the HVAC- related field. General courses in heat transfer, fluid mechanics, machine design, thermodynamics, and other related fields should not be counted toward this selective unless the coursework was included as part of an HVAC minor or specialty. Qualifying courses include:

- Air or hydronic distribution systems design
- Building energy analysis
- HVAC
- Control systems design and analysis

OR

6 months' experience in one or in a combination of more than one of the following:

- HVAC design
- Demand side management analysis and implementation
- Cogeneration
- Valve engineering

### **394 Mechanical Engineering**

6 months' experience, 12 semester hours, or a combination of both in the branch of engineering concerned primarily with the industrial application of mechanics and with the production of tools, machinery, and their products.

### **650 Sanitary Engineering**

6 months' experience, 12 semester hours, or a combination of both in the engineering discipline concerned with the improved sanitation of human communities – such as assuring a supply of healthy drinking water, treatment of waste water and removing garbage from inhabited areas.

### **662 Structural Engineering**

6 months' experience, 12 semester hours, or a combination of both in the field of engineering that deals with buildings, non-buildings or machinery or any item where structural integrity affects the item's function or safety.

## Fine Arts

### **015 Art**

6 months' experience, 12 semester hours, or a combination of both. The instruction of others and developing/supervising projects requiring art could be included.

### **109 Curator – Museum Management**

6 months' experience, 12 semester hours, or a combination of both in the overseeing and management of a museum

## History and Archeology

### **012 Archeology**

6 months' experience, 12 semester hours, or a combination of both. Archeology is a main branch of anthropology and refers to the study of past and current cultures through the study of artifacts.

### **013 Architectural History**

6 months' experience, 12 semester hours, or a combination of both. Architectural history refers to the field of study of architectural style which includes the theoretical basis of design and the evolution of design vocabularies and construction techniques.

## Categorical Selective List

### **277 History**

6 months' experience, 12 semester hours, or a combination of both where a knowledge of history and the ability to share/apply that knowledge were major competencies required by the job and where history was in some way applied as a major job function such as:

- Historian

Possession of the ability to speak, read, and write Spanish fluently.

### **867 Arabic Language Fluency**

Possession of the ability to speak, read, and write Arabic fluently.

### **869 English Language Fluency**

Possession of the ability to speak, read, and write English fluently.

### **878 Bi-lingual**

Possession of the ability to understand, speak, read, and write a second language (other than English).

### **897 Laotian Language (Customer Service)**

The ability to understand, speak, read and write Laotian to provide services to Laotian customers.

### **939 Burmese Language**

Possession of the ability to speak, read, and write Burmese fluently including such dialects as Karen, Karenni, and Chin.

## Law and Government/Policy

### **047 Legislative Liaison**

12 months' experience in professional level staff work for a legislative body or legislator at state or federal level; prior service as a legislator at the state or federal level or prior legislative/lobbying experience. Interns, pages, or those performing clerical work do not qualify under this selective.

### **336 Law Enforcement**

1 year experience.

### **339 Jailer/Jail Administration**

6 months' experience, 12 semester hours, or a combination of both.

6 months' experience involving:

- Contract Law
- Administrative law
- Legal research and writing
- Corporate law/corporate structure
- Public law

OR

12 semester hours covering coursework in:

### **354 Law Degree**

Possession of a law degree from an accredited institution.

### **355 Law Enforcement (Includes Investigating Criminals)**

6 months' experience, 12 semester hours, or a combination of both.

### **373 Legislative Assistant**

6 months' experience monitoring and tracking legislation for a legislator or state agency, inclusive of bill reviews and fiscal note review, as well as preparing both oral and written responses to requests for information; prior experience as a legislative assistant or intern at the state or federal legislative level, or prior experience working with lobbyist.

### **521 Paralegal/Legal Assistant**

6 months' experience, 12 semester hours, or a combination of both in research and analysis. Secretary or clerical work in a law office does not count towards the selective.

### **720 Policy Development**

6 months' experience, 12 semester hours, or a combination of both in the development of written documents that will create policies, standards, and procedures.

### **970 Elections**

1 year of experience in city, county, state, or federal elections offices. The following should not qualify as experience for the selective:

- Campaigning
- Polling precinct volunteer
- Political science coursework

## Mechanical

### **024 Air Conditioning (Heating/Refrigeration)**

6 months' experience, 12 semester hours, or a combination of both in one or in a combination of the following: Testing/repairing parts, installing units, communicating to customers repair issues; teaching others how to test, repair, install units, and communicate issues to customers.

### **148 Diesel Engine Mechanic**

6 months' experience, 12 semester hours, or a combination of both in the maintenance or repair of diesel engines. This could also refer to the teaching of others how to maintain or repair diesel engines.

### **315 Industrial Paint (Pressurized Spray Equipment)**

6 months' experience, 12 semester hours, or a combination of both.

- The surveillance for respiratory diseases, vector-borne diseases, enteric diseases, antimicrobial-resistant agents, or other infectious or non-infectious diseases
- The development of protocols and procedures for data collection and analysis, ongoing analysis of data using a variety of databases and statistical analysis programs
- The development and dissemination of written reports, graphs, tables, etc.

#### **225 Dental Hygienist**

Possession of an active license, as issued by the Iowa Dental Board, to practice as a Dental Hygienist in the State of Iowa.\

#### **247 Physical Activity**

6 month's experience, 12 semester hours, or a combination of both in exercise science, physiology, kinesiology, physical education, sports management, athletic training, recreation, nutrition, health education, physical activity promotion, healthy lifestyle management, or a closely-related field. ### **453 Nursing**

6 months' experience, 12 semester hours, or a combination of both in:

- General professional nursing experience (which could have come from several different programs)
- Nursing education
- Licensed practical nurse experience and training

This selective has a broader range of education and experience than the selectives for Registered Nurse. The applicant needs to have had some exposure to the field but does not necessarily have to be a registered nurse. Do not consider less technical backgrounds such as nurses' aide.

### **455 Nursing Education (Curriculum Evaluation)**

6 months' experience, 12 semester hours, or a combination of both.

### **523 Pediatrics**

6 months' experience, 12 semester hours, or a combination of both in the branch of medicine that deals with patients aged 18 or younger.

### **535 Public Health**

6 months' experience, 12 semester hours, or a combination of both related to improving, maintaining, and protecting the general condition of health within society, either on a personal, institutional, organizational, or community basis.

Experience may be gained from direct provision of health care or from other ancillary programs and support mechanisms such as government public health departments.

### **539 Psychiatric Nursing**

6 months' experience, 12 semester hours, or a combination of both in nursing specifically in the area of psychiatry.

### **590 Radiological Health**

6 months' experience, 12 semester hours, or a combination of both in the art and science of protecting human beings from injury by accidental exposure to radiation, as well as of promoting better health through beneficial applications of radiation.

*Note: This selective is to be used to facilitate noncompetitive appointments for disabled veterans in accordance with Iowa Code 8A.402(2)(f)(3)(c).*

A person who served in the active military, naval, or air service, and who was discharged or released therefrom under conditions other than dishonorable.

6 months' experience, 12 semester hours, or a combination of both in organizational development at the professional or managerial level that include at least one of the following major functions: Organizational analysis and design; Change and transition management; Performance management systems; Leadership and team development

### **112 Civil Rights/Affirmative Action**

6 months' experience in a capacity directly related to the provision of civil rights/affirmative action guidance or assistance to the public or clients, generally found in some level of government, in a non-profit service organization, or in a law firm specializing in this type of law. Application must demonstrate awareness of civil rights/affirmative action laws and public policies.

### **193 Employment Service Programs**

6 months' experience, 12 semester hours, or a combination of both in recruiting customers to utilize services provided by federal, state and/or local governments, private companies, or non-profit agencies involved in economic development, business expansion and worker recruitment.

Six months' experience facilitating teams using Lean methodology, tools and strategies that included the following major functions:

- Project selection, the establishment of project priorities and objectives and selection of team members
- Change and transition management
- Leadership and team development
- Facilitation of cross-functional teams through complex process changes using Kaizen, Design for Lean, 5S or other Lean methodologies
- Project status monitoring

### **736 Business Process Improvement**

Successful candidates must possess the equivalent of 6 months' full-time experience leading business process improvement events, utilizing Kaizen and other continuous process improvement techniques.

### **752 Vocational Rehabilitation**

6 months' experience, 12 semester hours, or a combination of both that specifically relates to employment and training services for individuals with disabilities. That knowledge base will include an awareness of the unique needs of this population, laws relating to discrimination or reasonable accommodations, assistive technology, and an understanding of employment and training systems and services, especially as provided in Iowa.

### **904 Applicant Selection**

A Master's degree in industrial/organization psychology or 6 months' experience in the development and application of employee selection devices which included the following:

- Conducting and documenting job analysis of essential functions and the competencies (knowledge, abilities, skills, and personal characteristics) required to do the work of jobs.
- Constructing education and experience rating devices, assessments, applicant questionnaires, and other applicant selection and related scoring devices.

### **927 Human Resources Information Systems**

6 months' experience in the use of HRIS which is an information system that provides a single, centralized view of the data that a human resource management (HRM) or human capital management (HCM) group requires for completing human resource (HR) processes.

### **980 Strategic Planning**

6 months' experience, 12 semester hours, or a combination of both. Generally, an administrative position (mid to upper level of the management team) is assigned this as one function of their overall job. However, there are some specialists

who deal only in strategic planning. Some colleges and universities may now carry this as a major or area of emphasis as part of their business administration or public policy programs. For experience to count, the applicant must have had the responsibility either for coordinating or developing the organization's strategic plan. Sometimes an administrative assistant-type is responsible for a lower level of coordination, i.e., distributing information to managers, collecting what they develop, and putting it into one document; that is not what is sought here. This has to be experience to the point that the individual knows the following:

- What a good strategic plan looks like
- How to prepare a plan
- How to monitor progress and ancillary planning
- How to speak knowledgeably for the organization about the plan

6 months' experience in a technique of relief printing using a printing press.

6 months' experience, 12 semester hours, or a combination of both, in commercial printing, which includes the reproduction of text and images carried out as an essential part of publishing and transaction printing; and direct customer interface, which includes two-way exchanges designed to understand customer needs and anticipate customer problems.

#### **483 Offset Printing**

6 months' experience in a commonly used printing technique in which an inked image is transferred (or "offset") from a plate to a rubber blanket, then to the printing surface.

#### **532 Printing**

6 months' experience, 12 semester hours, or a combination of both.

### Psychology

#### **114 Chronic Mental Illness**

A minimum of 1 year of full-time (or equivalent part-time) experience in delivering or coordinating services for adults with a persistent mental and emotional disorder that seriously impairs their functioning relative to such primary aspects of daily living as personal relations, living arrangements, or employment. This would include, but would not be limited to:

- Positions such as case managers and nurses affiliated with community support programs at community mental health centers
- Residential counselors and group home parents in community alternative living programs as well as residential treatment workers, nurses, activities specialists, and other treatment staff who work at state MHs (Cherokee, Independence, Clarinda, and Mt. Pleasant).

Experience in an outpatient setting should not be counted toward this selective, unless such experience can be demonstrated to have been with clients with chronic mental illness.

#### **115 SED (Seriously Emotionally Disturbed)**

6 months' experience, 12 semester hours, or a combination of both in the delivery or coordination of services to seriously emotionally disturbed children. Children with a serious emotional disturbance are persons: From birth to age 18, who currently, or any time, during the past year have had a diagnosable, mental, behavioral, or emotional disorder of sufficient duration to meet diagnostic criteria specified within DSM-V that resulted in a function impairment which substantially interferes with or limits the child's role or functioning in family, school, or community activities.

#### **146 Disabilities**

6 months' experience, 12 semester hours, or a combination of both in one or in a combination of the following:

- Deaf education

Experience generally obtained from either some level of government organization or a non-profit organization delivering these services. Must demonstrate exposure to the basic concepts of human/social services and related policies and procedures. Programs include those traditionally under the purview of the Department of Human Services, such as but not limited to:

- Child and family welfare
- Medicaid
- Entitlement programs
- Income maintenance
- Mental health
- Development disabilities
- Child support recovery

### **397 Mental Health**

6 months' experience in providing service, treatment or assessment to those affected by mental health challenges, either in a private setting, group homes, local assistance agencies, or state or privately-run treatment institutions. Application must demonstrate that applicant has received a general orientation to the symptoms and treatment protocols for mental illness or public policies, procedures, or applicable laws related to the topic, or assistance programs for those affected by mental illness. Experience may come from public, private or non-profit organizations.

### **407 Psychology**

Master's degree in psychology and one year professional psychology experience.

### **545 Intellectual Disability**

A minimum of one year of full-time (or equivalent part-time) experience in delivering or coordinating services for persons with significantly sub-average general intellectual functioning existing concurrently with deficits in adaptive behavior manifested during the developmental period. This would include, but would not be limited to:

- House parents and counselors who work at group homes
- Sheltered work or work activities staff
- Treatment staff affiliated with the state resource centers at Glenwood and Woodward

### **546 Intellectual Disability and Developmental Disabilities**
