Accessing your retirement account

Go to **www.massmutual.com/iowaric** and select "Login."



At www.retiresmart.com select "Login."

If you have an existing account, click "Login." If you are a new user, click "Create Account."



For existing accounts, you will be guided through steps to establish new, stronger and more secure usernames and passwords. In addition, you will choose security questions and have the opportunity to register your device.

To designate or change your beneficiary:

- Go to the My Account drop-down menu and click Personal Info under the Everything Else section.
- 2. Select **Add Beneficiary.** Make your selections, then click **Continue** and then **Save**.
- 3. Select **Change Beneficiary** to change any existing beneficiary information. You may then be asked to contact your Plan Administrator or complete the Beneficiary Designation form.

Rules to keep in mind when determining your beneficiary — You can use the online beneficiary process if you are single, or if you are married and you want to declare your spouse as the sole primary beneficiary. But, if you are married and want to declare someone other than your spouse as your sole primary beneficiary, you must print the form available online and

To add or change your email address online:

 Go to the My Account drop-down menu and click Personal Info under the Everything Else section.

complete it according to the instructions.

- Select "Add or Change Email" or "Change Address" (depending on your available options). Type in the email address from which you would like to receive electronic communications.
- 3. Confirm the email address.

Once you review and approve all changes made to your account, click **Submit**. You will receive a confirmation number when your transaction is complete.

How much should you save for retirement?

To access the RetireSmart Ready tool, be sure to enable pop-ups from the participant website.

The RetireSmart Ready Tool is an online analysis tool that gives you a simple way to assess your current income gap given your current retirement strategy. The tool can also provide different levels of suggestions that may help close the income gap and drive towards a successful retirement.
